Does Hollywood Ever Get It Right?

"My second career is going to the movies." Our speaker, Mike Canning, has long been fascinated by Hollywood's foibles, making his first visit to the "flickers" in Fargo, North Dakota, at the precocious age of four, hence inspiring this second career — going to the movies. His recent book, Hollywood on the

Potomac, offers the first comprehensive look at the intersection of the capital city and the movies. In examining more than 50 motion pictures, he reveals how Washington, D.C. has been treated as subject, setting, or background in American feature films. Beyond Washington's tourist-friendly monuments and museums, he opens up a world exposed by moviedoms's love-hate relationship with this city.

From the idealism of *Mr. Smith Goes to Washington*, to the sharp wit of *Born Yesterday*, to the paranoia of *Seven Days in May*, and to the "goofs" of location as seen in *No Way Out* and many other films, Hollywood's visual images make an impact on all of us, for good or bad. Mr. Canning will tell us much about the treatment and mistreatment of our city in films by showing us film clips to illustrate his points.

In his first life, Mr. Canning was a Foreign Service Officer for 28 years, working as a press and cultural officer in eight countries and four continents. A movie reviewer for the *Hill Rag*





Short biographies of these individuals are provided below:

President — Ed McKnight

Ed currently serves as President of the Board of Directors. He has served as Vice President and Chairman of the Budget and Finance Committee. He is also a member of the Curriculum and Scholarship Committees and previously served as Board representative for the Special Interest Groups, as class coordinator for many classes, and as instructor for several classes. Ed received a BS degree from The Citadel and MA and EdS degrees from Appalachian State University. After retiring from the Army, he worked a series of jobs in Egypt and Haiti before settling down to work with various defense contractors in the Washington area. He enjoys exercising, gardening, reading, travel, and LLI.

Vice-President — George Chalou

George has belonged to LLI since 2008 and enjoyed the many opportunities of the organization. He feels that serving on the board of Directors is a way of providing for the future health of the organization. As a Board member for the past three years, George has provided guidance on the records of the organization — especially on the disposition of temporary records.
