years, and discuss how major reforms have improved both programs. Additionally, he will look at the challenges currently facing both programs and outline the policy choices that need to be made if promises are to be kept for current and future generations.

Mr. Kallio has worked for AARP for 25 years; since 1995, he has served as Director of Virginia's operations, overseeing AARP's program, community service and advocacy activities within the commonwealth. As a senior program specialist, he directed AARP's national Widowed Persons Service with over 230 sites across the country. Later he served as a legislative representative, organizing AARP's federal advocacy activities and developing grassroots volunteer activities in six states. AARP has more than 40 million members, with staff offices in all 50 states, the District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Please join in welcoming Mr. Kallio, who is coming from Richmond to be our Forum speaker. In addition to his main topic, there will be an opportunity to learn about some of AARP's new programs and to ask questions on other issues.

October food donations will go to Ecumenical Community Helping Others (ECHO), formed in 1968 by representatives of nine Springfield churches who met to address the social needs of the community, on an ecumenical basis, with lay persons assisting the community without clergy leadership.

Currently, ECHO represents 26 congregations in the Springfield and Burke areas, is entirely staffed by about 400 unpaid volunteers, and spends less than 4% of its income on administrative expenses.

ECHO distributes donated food, clothing, school supplies, household items, and holiday baskets; offers ESL and computer classes; and provides emergency financial assistance and emotional support. The organization participates in Meals-on-Wheels and shares excess donations with other charities, including Medical Missions, The Salvation Army, and American Rescue. ECHO is proud of its policy that no client pays for any assistance received.

Although any non-perishable food is appreciated, the following are currently in low supply at the pantry: **dried beans, box potatoes, muffin mixes, canned meat, baked beans, mac and cheese, tuna, spaghetti sauce, rice, tomato sauce and paste, canned tomatoes, condiments (mustard, ketchup, mayonnaise),** and **deodorant.** Martie Klee will deliver our donations to ECHO.

Our year was off to a great start as members generously filled five grocery carts to the brim with their contributions to Committee for Helping Others. Thank you so much.



A Longwood Holiday Tour....Get in the spirit

How quickly summer is passing! Before long we will have crisp cool air, the smell of balsam in the air and jingle bells being rung. To celebrate the upcoming holiday season, we invite you to experience the traditions of the past and dazzling entertaining displays in a special wintertime visit to Longwood Gardens in Pennsylvania.

Wander through half a million twinkling lights, thousands of poinsettias, and magnificently adorned trees. Beautifully lit fountains dance in the garden's starry holiday wonderland and concerts are presented daily. Longwood's Conservatory is one of the world's great greenhouse structures. It shelters 20 indoor gardens and 5,500 types of plants. The Conservatory, which was built in 1919, has been periodically expanded and renovated and is beautifully decorated for the holidays. This event is both indoors and outdoors so visitors should dress accordingly and wear comfortable shoes. To see all of the outdoor lights, there is ample walking involved.

We will leave at 9:30 am sharp (please arrive no later than 15 minutes before departure time) from the Little River United Church of Christ, 8410 Little River Turnpike, Annandale (across from the Northern Virginia Community College). 
