LLI/NOVA Coronavirus Guidance

March 13, 2020

With recent concerns regarding the coronavirus (COVID-19), we are continuously monitoring information on the spread of the coronavirus to make sure that we balance our members' health and safety with service to our mission. This is especially so because we are an at-risk group; so simply following Fairfax County Public School (FCPS) and Northern Virginia Community College (NOVA) closing guidance may/may not be relevant for us.

Effective immediately, all LLI/NOVA activities, (i.e., Forums, classes, SIG meetings, and day trips) are canceled through Sunday, April

19. Future LLI/NOVA activities will depend on the status of "community spread" of the disease and guidance from sources such as the Centers for Disease Control and Prevention (CDC) and Fairfax County Health Department. Also, we will continue close communication with the vendor and members registered for the Study/Travel 2020 trip.

We will make decisions in the best interest of the majority of our members, but we recognize that everyone's needs, and sense of safety vary. Working together we will manage our responses to the virus effectively. Our website will be updated accordingly.

Special guidance to members who have traveled outside of the US since the COVID-19 pandemic. Once LLI/NOVA resumes activities, we request that all attendees, instructors, and class coordinators self-isolate from LLI/NOVA activities for at least 14 days from their travel return date.
