

# LLI Board Holds Its Third Annual Retreat

September 2000 Volume 4 – Number 6 hirteen Board members and four LLI members serving in key operational positions met on July 26 for an all-day planning retreat at Greenspring Village. The participants took stock of LLI as it begins its fifth year and formulated plans for the future. President **Alan Mayer** observed that LLI could be proud of its progress and encouraged exploration of ways in which the Institute can build on its solid foundation.

Discussions throughout the day were within the framework of a comprehensive five-year strategic plan, which had been prepared in advance by newly-elected Board member **Memphis Norman**. The plan includes a number of recommendations for preparing LLI to meet future demands and provides a basis for tracking progress.

It was noted that three of the "interest groups" initiated last spring have been successful (theater, games, and topical discussion), while the financial forum interest group is facing an uncertain future. The Special Events Committee is considering scheduling Sunday afternoon activities during the winter, such as a series of teas followed by vintage movies, as well as cultural events.

## **Membership and Finances**

LLI began in 1996 with 38 members. Considerable discussion was devoted to how many members LLI can adequately and appropriately serve, since it has experienced significant growth in just four years. Membership totaled 239 as of June 30 (up from 167 a year ago); as of the Retreat there were 243 members. Because LLI uses dispersed locations for its classes, physical space is not presently a major concern; however, the Board recognizes that members prefer class sizes that foster discussion and interaction. Also, several have expressed the hope that LLI membership will remain at a level where socializing can continue.

The operating budget for the current fiscal year is based on revenue from 275 members, with no increase in dues. It is possible LLI will not have to grow much beyond, perhaps, 300 members to sustain its operations while preserving "organizational intimacy." Discussions ensued as to what extent we need to recruit new members with the 275 level close to becoming a reality. The Board will assess this subject further after the results of upcoming membership renewals are known (181 are due September 1, 2000).

#### **Programs**

Ways were explored for LLI to offer a variety of courses, as well as trips and other activities just

for "fun." A process has been initiated for planning course offerings on a year-round basis, and efforts are intensifying to recruit more college-level faculty. Videos will be acquired when appropriate to enhance course content, and the Board will explore how such videos can be made available to interested members unable to take a particular course.

#### Outreach

Knox Singleton reported on community service activities available to LLI members, another important aspect of continuing education. He urged participation in NVCC classes, such as the ESL program, and encouraged having an Institute presence at Alzheimer's Memory Walks this fall. Knox also observed that LLI could contribute to the growing desire of seniors for lifelong educational experiences by helping with the formation of similar institutes at nearby college campuses. Advisory assistance already has been made available to a group hoping to start a program at NVCC Loudon.

#### June Forum/Annual Meeting

This year's Study/Travel program has been very successful, with 20 LLI members traveling to France in June, and 14 heading to Germany in September.

A Bylaws amendment was approved unanimously to delete the phrase "for one year" from Article V.1. Members, which now reads in part, "If the immediate past president does not continue as a Director s/he may serve as an ex-officio Director with voting privileges."



# **LLI Community Outreach**

The Memory Walk held in the fall of each year is the primary fund-raiser for the Northern Virginia Chapter of the Alzheimer's Association. The money raised enables the highly-dedicated staff of this non-profit organization to provide a range of vital services to the increasing number of patients and family care-givers who are struggling with this fatal disease. Services include a phone Help line, a Safe Return Program for wanderers, the organization and operation of Support Groups for over-stressed care-givers, an extensive program of public information and education about all facets of the disease, research, and political action at the local and state levels of government.

The LLI Board of Directors is promoting certain community outreach activities that can be identified with the collective LLI membership. The Alzheimer's Memory Walk program is particularly worthy of our support. # **LLI/NOVA Student Award Program**

As our sponsoring institution, NVCC provides free office space to LLI, free use of the Cultural Center, parking for members and guests, access to the College bookstore and library, and other miscellaneous services. In return, LLI tries to contribute to the life of the student body on the Annandale Campus by assisting the faculty/staff in various ways.

A major step was taken last year with the establishment of the LLI Student Award Program.
