# U.S. and China: Conflict Ahead?

he November 5 Forum presentation will be an up-to-date look at China. The speaker, Dr. Ellen L. Frost, is a Visiting Fellow at the Institute for International Economics in Washington, D. C. She holds a Ph.D. from Harvard's Department of Government, where she specialized in Chinese politics and development, and she recently co-chaired a two-volume study for the U.S. Navy and Marine Corps on the impact of globalization and development for Washington-based M.A. candidates from Syracuse University and the University of Pittsburgh. Dr. Frost has served in a number of government and private sector positions, including Counselor to the U.S. Trade Representative. She is a frequent speaker and writer on international affairs, especially Asian and

### Directions (for those traveling by car):

Traveling North on I-95/-395: after you pass the Glebe Road exit in Arlington, take the next exit marked 8A Washington Blvd./Fort Myer. Bear left onto Washington Blvd. The third exit (approximately ½ mile on the right) will read Ft. Myer. Enter the Post at this point (Hatfield Gate). Turn left on Sheridan Ave. and proceed to the Officers Club on the left. You will pass Pershing Drive. Parking will be on the right and also on the left past the Club. You may wish to verify this route on the day of the event with the Officer at the Gate.

Traveling East on Route 50: proceed past Washington Blvd. to traffic light at Pershing Drive. Turn right into the Henry Gate of Ft. Myer. Turn left on Sheridan Ave. and proceed to the Officer's Club on the left. See comment about parking above.

On October 19, Acting Social Security Commissioner Larry G. Massanari announced a 2.6 percent increase in Social Security and Supplemental Security Income (SSI) payments. The Cost-of-Living Adjustment (COLA) will begin in January 2002 for people who receive Social Security. For people who get SSI, the increase will start on December 31, 2001.
