U.S. Foreign Policy in the Middle/Near East

t our January 7 Forum, American University Professor Samih K. Farsoun laid out the background of religious movements of all religions world-wide. Some of the issues covered were: internal and external factors, post-World War II, the Cold War, how nationalism led to anti-colonialism, formation of the Arab League, movements against U.S. interests – especially oil (BP in Iran and Aramco-Saudi Arabia-nationalized), Communist attempts, and infiltrating Middle East countries, plus creation of the State of Israel, the Palestine question, etc.

Our February Forum speaker will be a representative from the U.S. State Department, who will provide the background of U.S. foreign policy during the past 50 years in the Middle and Near East. It is essential to understand what the world situation, vis-à-vis the Middle East, was post-World War II and the Cold War period, in order to more fully comprehend U.S. foreign policy during the last half century.

It is my intention to conclude this series of Forum presentations at our March 4 Forum with a speaker from the legislative segment of the U.S. Government, who will cover our political process and its impact on U.S. foreign policy during the past 50 years in the Middle/Near East.
