on Northern Virginia's Sales Tax Referendum!

alegates Vivian Watts and Jay O'Brien will square off at LLI's monthly Forum on Dctober 7 discussing the pros and cons of the referendum on a sales tax increase to pay for transportation projects in Northern Virginia. Del. Watts (D-39th Dist.) will describe why voters should say "yes" on this ballot initiative. Del. O'Brien (R-40th Dist.) will urge voters to vote "no."

In addition to the sales tax issue, other initiatives on the ballot on November 5 include voter approval of two amendments to the State Constitution, two proposed State bond issues, and three County initiatives. Sample ballots and brochures will be available to help voters understand these issues.

Del. Watts served in the House of Delegates from 1982-1986. She was appointed Secretary of Transportation & Public Safety in 1986 and served four years in this position during Gov. Baliles' administration. She was reelected to the House in 1986 where she currently serves.

Del. O'Brien has served in the House since 1992, having successfully won election six times. Currently he is a candidate for election to a vacant seat in Virginia State Senate District 39, a new Northern Virginia Senate District created by redistricting in

Explanation of Capital Gains Election

Starting in 2001 there is a new tax rate for super long-term capital gains (super long-term is over five years). The new rate is 18 percent versus 20 percent on assets held over one year.

Assets acquired prior to 2001 generally do not qualify for this new rate. However there is an election to pretend an asset was sold on January 1 (a deemed sale) solely to start the five-year holding period and qualify that asset for the new lower 18 percent rate.

If the election is made, any gain from the deemed sale is recognized as of that date, and any loss realized is disallowed for

all tax years. The election is irrevocable and is made by reporting the sale on your tax return with a statement of explanation. To make the election you will need to know the Fair Market Value of the asset on January 1, 2001 or, for securities, the closing market price on January 2, 2001 and your cost basis in the asset.

This election would almost never be advisable for a loss asset, an asset with a large gain or one with a holding period approaching one year. In addition to losing forever the benefits of unrealized losses, or recognizing gain but not cash from an asset, and losing any prior holding period in the asset, the taxpayer is being asked to gamble that any disadvantage from the election will be outweighed by gains realized over five years in the future that are so large as to make significant the two percent difference in the tax rate.
