his is the topic to be addressed by Laura Feldman, the guest speaker at our June 7, 2004 Forum meeting. She brings her skills as a teacher to educating senior groups and activists across the country. Ms. Feldman has an extensive working knowledge of long-term care and healthcare issues, as well as Social Security and Medicare, and is a professional advocate and lobbyist for older Americans, believing that the political realities of an aging population are important to all generations. She brings her observations and perspective from "inside the beltway" on the politics of the 108th Congress. Demystifying politics, personalizing them, and making it fun is one of her goals.

Ms. Feldman has been a grassroots organizer for the National Committee to Preserve Social Security & Medicare for the past 13 years. She is a graduate of American University; past president of the Southern Gerontological Society; on the Board of Trustees for the Florida Silver Haired Legislature; was the first Policy Chair for GROW (Grassroots Organization For The Well Being of Seniors); served on the Board of the Maryland Gerontological Association, the Virginia Council on Aging, and NANASP (National Association of Nutrition and Service Providers). She was appointed to the Seniors Cabinet of the Montgomery County Council of Maryland.

Thank You — But Not Goodbye


