## An Ancient Discipline and Holistic Approach to Restore Health

Many Americans are skeptical of Eastern medicine. The public seems unwilling to trust alternative therapies, but it wants answers to medical questions that go beyond the orthodox approach to treating illnesses. As a Senior Consultant with the University of Maryland, Center for Integrative Medicine, Dr. Jonathan Gilbert's work has attracted attention for integrating Eastern and Western medicine. A practitioner of Chinese herbal medicine Dr. Gilbert will talk to us about using herbology and acupuncture to resolve or arrest chronic issues such as Fibromyalgia and Lyme disease. He will also discuss how this approach works in concert with Western medical protocols.

The Forum room is located on the second floor of the Ernest Cultural Center, NVCC Annandale. Coffee and refreshments will be served at 9:30 a.m. and the meeting will begin promptly at 10:00 a.m.
