# Honoring Valor, Fidelity, and Sacrifice

Proportionally the small town of Bedford, Virginia, suffered the nation's severest WW II D-Day losses. Nineteen lost their lives at Omaha Beach and two more soldiers died later in the Normandy Campaign. As we approach Memorial Day, it is fitting to learn more about this tragedy. Jeffrey Fulgham, Director of Development, will talk with us about the National D-Day Memorial in Bedford erected to celebrate and preserve the legacy of D-Day.

## Phishing — High-Tech Identity Theft with a Low-Tech Solution

Have you ever got an e-mail asking you to confirm your account information from a bank or a company that you have never done business with? The e-mail looks official, and it even has a link that appears to take you to the company's website. The e-mail you have received is actually from an identity thief. These crooks are hoping that people who have an account with the business will click on the link and submit their account information for verification purposes. They are "phishing" for account information. Phishing is a sophisticated way to lure you to phony websites where you voluntarily surrender your passwords and account information to identity thieves without realizing it.

These types of e-mails often threaten you, e.g., you must take action within a limited time or the consequences will be dire. Some AOL customers received a phishing e-mail stating if they did not verify their account information within 24 hours, their service would be terminated. Other phishing e-mails will state your account has been flagged or has a problem, and the account information needs to be verified. We received an e-mail for PayPal that stated our account had been flagged and we needed to verify our information. This identity thief was lucky. We do have an account with PayPal. We opened the e-mail, and it appeared to be legitimate. We clicked on the link that purported to take us to https://www.paypal.ae.com. The site looked like *PayPal's* website. The web page asked for our account information for verification purposes. We knew right away, however, that it was phony because our PayPal account had been opened with another e-mail address. This particular site has been shut down, but that doesn't mean the identity thief was caught. You could receive a phishing e-mail from the same thief tomorrow. What can you do to avoid such a trap?

First, realize reputable companies will never send you an e-mail asking you to confirm your account information. The e-mail will look authentic and this may cause you some concern. If this is the case, you can always call the company and ask about your account. An alternative to calling is checking your account online. Do not click on the link in the e-mail. Log completely out of your e-mail, open another window, and type in the company's web address to verify your account.

You're probably thinking why would you want go to the trouble of closing your e-mail and opening another browser window. The link in the e-mail is a cloaked redirection link that will take you to another website that is *not* associated with the company. A cloak link will show you the correct web address when you move your mouse over it. If you do click on that link, the web address, or URL, will be similar to the company's address, but it will not match exactly. The website will look just like you expect it to look. The web page will ask for your account information. You're just one click away from submitting your account information to the identity thief. We went to the actual *PayPal* website and, sure enough, our account was okay.

Identity thieves have been known to attach a file to a phishing e-mail. The attachment contains a program to transmit your personal information on your hard drive to the identity thief. You will never know the program has been installed on your

computer. Never open an e-mail attachment unless you specifically requested it and are expecting an e-mail with an attachment. The phishing e-mail may be from someone you know. His or her computer could be infected with a virus that sends e-mail to everyone in his or her address book. Delete the e-mails with attachments without opening the e-mail.

Finally, if you get an e-mail that is phishing for your information, forward it to spam@uce.gov. If you know how open the e-mail headers, cut and past that information into the e-mail to help the FCC track down these identity thieves.
