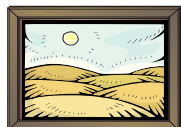

At the helm of the Board are the four officers who are elected annually in June. President Norma Hughes has served for almost three years. Besides preparing for and conducting Board meetings, she presides at the monthly Forum and at social functions. She also serves on several committees, including the 10th Anniversary Committee. Paul Hopler, Curriculum Chair, represents that committee. Doug Johnson chairs LLI's Study Travel Group and is the Board's Scholarship Committee representative. Curt Kornblau co-created the LLI Strategic Plan and periodically assesses the organization's adherence to it. Betty Mahon, Special Events Coordinator, oversees LLI's social events. Liddell McLeod, Assistant Secretary, also wrote and edited the newsletter. Don Reynolds is Historian who also served as Committee Chair for LLI's 10th Anniversary. Mary Underwood is the Records Manager who coordinates changes enacted to LLI's by-laws. Board members are also active on various committees and with interest groups.

## Annual Report to the Membership (July 1, 2005 – June 30, 2006)

The Lifetime Learning Institute of Northern Virginia (LLI) can proudly point to another successful year, a year in which we prepared for our 10th Anniversary and held the first of three celebration events.

LLI was initiated in 1996, through the efforts of 38 determined and energetic individuals who successfully established our educational program for seniors. Over the past 10 years, LLI has attracted many people to its programs and as of June 30, 2006 our membership numbers 324. Although this number may fluctuate a bit during a given year, we continue to maintain an acceptable (and operationally manageable) membership level with minimal publicity. It is our members who provide effective publicity and recruitment of new members through "word of mouth," which reflects member satisfaction.

During the 10 years, we were able to maintain our annual membership fee at \$100. This has been primarily due to the members and instructors who volunteer their time and talents to our wide-range of programs and who are so essential to LLI's continuing success. We recognize and appreciate all who contribute. LLI is also fortunate to have the solid support of its sponsor—the Northern Virginia Community College (NVCC), Annandale Campus. During this past year, 11 faculty members offered classes on various subjects. LLI continues to benefit from the support and guidance of the campus Provost, Dr. Barbara Saperstone. We also appreciate Dr. Robert Vaughn's assistance along with his staff in the Office of Continuing Education and Workforce Development.

LLI's financial condition, as reported, shows that we are in a position to continue offering quality programs. As we celebrate our 10th Anniversary during 2006, it is our goal to continue providing an educational experience that may attract new members while continuing to address the interests and needs of our long-standing members. LLI will always be open to change and new ideas and resist the temptation to take on more than can be done well by its members who volunteer their time and talents.

The LLI Board of Directors and I thank you for your continuing interest and support. I trust you believe as I do that the next 10 years will also be our best.

## LLI Highlights for Fiscal Year Ended June 30, 2006

- 324 people were members in good standing (247 women, 77 men).
- 72 faculty members and lecturers (including 11 from the NVCC faculty) offered 82 courses at 20 separate locations.
- Nine Forum meetings were held with an average attendance of 144.
- Twelve educational trips were conducted (domestic and international).
- Eight special interest groups were offered.
- We had a wonderfully successful Anniversary Party in May and Picnic in September. Our Holiday Party was snowed out and was deferred to the next year.
- Two \$2,000 and two \$500 student scholarships, and one \$2,000 and one \$500 student leadership scholarships were awarded with the generous contributions of our members.
- LLI participated in the three-day Mid-Atlantic Regional Lifelong Learning Institutes Conference, which was held in September 2005 at Ashville, N.C.
- At monthly Forums, LLI members have generously donated and delivered several hundred pounds of food items to organizations assisting citizens in need.

# Consumer Tidbits

## Consider “ICE” — In Case of Emergency

If you carry a mobile telephone, consider putting ICE in your phone. Simply select a new contact in your phone book, enter the word ICE and the phone number of the person you wish to be contacted in case of an emergency. Having ICE in your phone will allow paramedics or police or rescue services to contact a designated relative (or anyone you name) in an emergency situation.

## Five Ways to Get Off the List

Here’s how to get rid of those unwanted catalogs that clog your mailbox or those annoying telemarketers.

**Coupons.** To end your coupon conundrum (like Valpak), go to [www.coxtarget.com/mailexpression/DisplayMailSuppressionForm](http://www.coxtarget.com/mailexpression/DisplayMailSuppressionForm)

You’ll need your Valpak to complete the removal request.

**Direct Mail.** Catalogs, advertisements, bank offers, etc. Register for the Direct Marketing Association’s Mail Preference Service at [www.dmaconsumers.org](http://www.dmaconsumers.org) and click on Consumer Assistance. If you want certain direct mail, go to [www.directmail.com](http://www.directmail.com) and choose what you are interested in receiving.

**Pre-approved Credit Card Offers or Insurance Quotes.** Log onto [www.optoutprescreen.com](http://www.optoutprescreen.com) or call 1-800-567-8688. Complete the online form and consumer credit reporting. Companies such as Equifax, Experion, Innovis, and TransUnion will remove your name from lists used by creditors for five years.

**Sexually Oriented Advertisements.** If you receive such an ad or magazine, take it to your local post office and ask for Form 1500, Application for Listing and/or Prohibitory Order. You can stop that particular vendor and notify similar companies that you’re not interested in their products.

**Telemarketers.** Add your name and phone number—cell phone numbers are eligible, too—to the National Do Not Call Registry by going to [www.donotcall.gov](http://www.donotcall.gov). You must have an active e-mail account to register. Once you sign up, you will receive an e-mail asking you to complete your registration within 72 hours. Just click the link provided. Registration is good for five years.

## Recalls

Although some recalls are widely reported in the media, like bags of spinach recently, you may have to do some digging to learn about others. A good place to start is *Consumer Reports*. 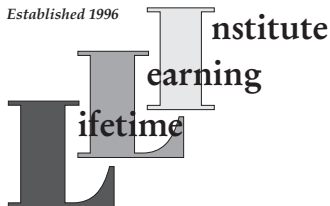
