Community Outreach Food Program

Our June 5 Forum conveniently coincides with the 2007 National Hunger Awareness Day. On this day, communities across the country will remember more than 35 million Americans suffering from hunger or food insecurity. The Arlington Food Assistance Center (AFAC) will be the recipient of LLI’s food donations in June. Many people in Northern Virginia think that hunger in Arlington is not a problem. Unfortunately, this is a myth. The AFAC distributes food to more than 600 families per week who rely on the supplemental groceries to make ends meet.

Besides items such as soap, shampoo, detergent, tissues, and diapers, the AFAC can use cereal, canned tuna, canned vegetables, peanut butter, pasta, pasta sauce, soup, and bottled juices. Gina Trapp will deliver our donations to the AFAC. As always, please don’t forget to check those expiration dates!

Congratulations to all of you who so generously brought food products to the Forums this past year. You have made the job of coordinator so easy. Since taking over the program, we have provided hundred of pounds of food to seven different food pantries.

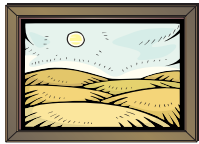

June 15: National Museum of the American Indian. Architecturally warm and inviting, this museum celebrates the life-ways, languages, literature, history, and art of Native Americans. Rock formations, lakes, rivers, forests, canyons, and mountains are significant and spiritual places for many indigenous peoples. These natural settings, as well as the native stone and masonry work, inspired the designers and architects to create a museum and landscape that leads us to a distinctly Native place. Native American persons will conduct a museum tour for our group, which will be combined with a larger group. We plan to join the 1 p.m. tour. We will then eat lunch in the museum's excellent restaurant, which serves Native American foods.

July 20: The Phillips Collection. America's first Museum of American Art has a collection of more than 250 paintings by both American and European masters from the 19th and 20th centuries. This specific exhibition, *American Impressionism*, will highlight paintings that were among the museum's earliest acquisitions such as Childe Hassam, Maurice Prendergast, Theodore Robinson, John Henry Twachtman, and Julian Alden Weir. As members of the first generation of American painters to absorb the technique, brighter palette, and subject matter of Impressionism from their French counterparts, these artists painted atmospheric landscapes, park and beach scenes, urban views, and charming interiors, with particular interest in optical effects, light, and different seasons. Our docent-led tour will begin at 10:00 a.m. Note: For non-Phillips members, there is a \$13 charge per person; no charge for Phillips members. Because up-front payment is required for this tour, we MUST know who is going by June 15, 2007.

Meet the Scholarship Award Winners

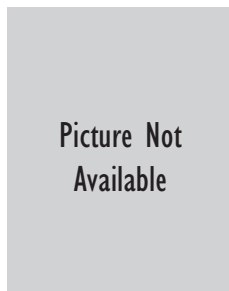

Driving: 395N over 14 St. Bridge. Straight on 14th St. to P St. Studio Theatre is on N.E. corner of 14th & P. Park on the Street or at 1617 14th St. LLC corner of 14th and Corcoran — 1½ blocks N of the theater: \$5.00 or Washington Plaza Hotel — 10 Thomas Circle, N.W., 14th and M St. three blocks south of the theater: \$5.00 with ticket stub. Street parking can be a challenge, so you might want to consider brunch at the Viridian, which is next door to the Studio. They have a small attended lot. First come, first served. Other restaurants are Logan Tavern, Mercado, and Playbook Café on P St.

Metro: From the Dupont Circle Metro stop, walk approximately 5 blocks east on P St. The theater is on the N.E. corner of 14th and P streets.

From McPherson Square Metro stop, walk approximately 7 blocks on 14th St. Theater is on the N.E. corner of 14th and P Streets. This is more uphill than from Dupont Circle.

The Fairfax Community Concerts Association has announced its 2007-08 four concert series. The concerts feature nationally recognized musical performers and are held at Oakton High School (on Sutton Road) at 3 p.m. on the Sundays listed below. Many LLI members already enjoy these pleasant musical afternoons, so consider gifting yourself and invite your friends.

The two 2007 concerts are:

September 30: On Broadway—A Broadway song review
November 11: California Guitar Trio—A group of virtuoso artists

The two 2008 concerts are:

March 16: IONA—A leading Celtic group
April 27: Tom Cunningham Orchestra—A big band.

Cost: Before September 1, 2007, the four concert series is \$40 per adult and \$20 for students. After September 1, the series costs \$50 per adult and \$25 for students.

LLI Scholarship Winners

Thanks again to our generous LLI members for making it possible for us to give scholarships to worthy students at the Northern Virginia Community College (NVCC). We had some outstanding applicants this year from both the Annandale and the Medical Education campuses.

Leadership Scholarships

Our winning candidate for the leadership scholarship (\$2,000) is Atanaska Dobreva from Bulgaria, majoring in business administration. While maintaining a GPA of 4.0, she is vice president for scholarship of the Phi Theta Kappa chapter, and a student senator. She also personally created a series of presentations to help students transfer to selected colleges and universities, and a committee to research scholarship opportunities for her fellow students. She has volunteered for the community. She wants to obtain a Ph.D. in economics, so that she can help her country transition from its communist past to a free market economy.

The second place for leadership (\$1,000) goes to Nora Sayasithsena, majoring in Dental Hygiene. As vice president of the Student American Dental Hygienist Association, she participates in planning and implementing the activities of this professional organization. She also participates in many community outreach activities in the dental field. She already has a degree in Biology from George Mason University. She wants to continue her studies by online courses after completing her time at NVCC, so that she can obtain a higher degree and, ultimately, return to NVCC as an instructor.

Academic Scholarships

We have two first place academic scholarships (\$2,000 each), which have been awarded to Sara Nourian (GPA 3.9) and Kathryn Rohr (GPA 4.0). Both these students also have strong leadership qualities. Sara, a business administration major, is president of Phi Theta Kappa. As such, she organizes many campus-wide and community-based activities. She also tutors foreign students, helping them adapt to their new surroundings. She plans to obtain a degree in accounting, become a CPA, and, ultimately, a lawyer. Kathryn Rohr already has a degree in Psychology and is now majoring in Dental Hygiene. She is president of her class and is very active in both on- and off-campus community activities. Kathryn is very dedicated to the rigorous field of dental hygiene and keen to help the community, both as a dental hygienist and as a volunteer.

The second place academic scholarships (\$1,000 each) will be awarded to Sung Ae Lee, a respiratory therapy student from South Korea, and Michelle Kouagnia Mbakop, an engineering major from Cameroon. Sung is on the Dean's list and is a Presidential scholar. She wants to continue after graduating from NVCC to obtain a B.S. degree in a 4-year college, and then to work in a hospital. Michelle is active in the NVCC community, as public relations representative of the African Student Association, and as a member of the women's basketball team. She is aiming for a B.S. in Chemical Engineering, so that she can help her countrymen in Cameroon, who she feels lack sufficient graduates in that field, especially in the field of environmental ecology.

Merit Awards

Because we had three more outstanding and deserving applicants, and some additional funds, the Committee recommended, and the Board approved, the award of three \$500 Merit Awards to Adelia Hessler, Yadco Sharif, and Randall Weisheit. Adelia (GPA 3.8, Nursing) is on the Dean's list and is a Presidential scholar. She is currently vice president (and will be president for 2007-8) of the Students Nurses Association and

co-captain of the team for Rally for Life of the American Cancer Society. She also volunteers in the community as a Firefighter EMT. Yadco (Dental Hygiene) is vice president of her class. She plans to obtain a B.S. at George Mason University, followed by an M.S. degree. Ultimately, she hopes to return to NVCC to teach. Randall (GPA 4.0, Liberal Arts) aims to earn 53 credits in one year at NVCC, so that he can enter the University of Virginia as a junior, where he plans to major in political science and business management, as well as play lacrosse. He hopes ultimately to become a politician.

All these students showed a deep commitment to their studies and to their fellow students. All found their time at NVCC to be very rewarding. Several expressed their gratitude to our organization for making these much-needed funds available to them.

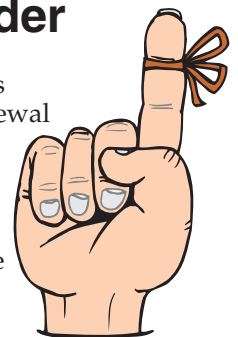
