
The Lunch Bunch

LLI Board Meets for Fifth Annual Planning Retreat

Let I's Board of Directors, joined by Knox Singleton, President Emeritus; Laura Charron, Administrator; Martie Klee, Volunteer Coordinator and EIN Liaison; and Louise Sousk, Trip Committee chair, met for an all-day planning retreat at Greenspring Village on July 18, 2002. President Lorin Goodrich conducted the meeting. Following is a summary of the topics discussed:

Operations

Lorin indicated that several areas need additional staffing:

- Membership: Gladys Keating and Mary Davis have agreed to help with membership functions.
- Assistant Treasurer: George Pearsall will serve in this capacity.
- Forum logistics: Lorin needs help with logistics for the monthly Forum meetings.
- Photographers are needed to supplement the efforts of Don Reynolds and Phil Waggener.
- Teachers: we need recommendations for teachers for new classes.

Volunteer Activities

- Martie Klee distributed samples of three different forms of member surveys for Board comment. A survey form is helpful in ascertaining where members' interests lie, both for class topics and for volunteering.
- There was some discussion of the ways to use volunteers and how to inform members of volunteer opportunities.

Nominating Committee

The Board agreed that the Committee should be appointed in January to allow sufficient time for selection of a slate and appropriate introduction of the nominees at a Forum meeting prior to the June Annual Meeting.

Strategic Planning and Mission

- Memphis Norman indicted that activities are on track against our strategic plan goals. Attendance at the monthly Forums averaged 153 per meeting for the year. New gains include: establishment of LLI's library and the involvement of more NVCC faculty in teaching courses. LLI's programs are of high quality, and the special interest groups offer timely and interesting topics.
- Knox Singleton expressed appreciation for LLI's efforts to encourage interest in classes focusing on Vital Aging; several topics in this category were suggested for future course offerings.

Financial Condition; Insurance

- Warren Hynes reviewed the FY 2002 financial report, and indicated that LLI is very healthy financially. Richard Risk presented the budget, which has a small surplus. The Budget Committee will meet in August to review actual expenses and decide how to budget the surplus. The Committee also will prepare a Rainy Day Fund plan for presentation to the Board.
- John Manion shared information he had obtained from four companies on Directors and Officers Insurance. Alan Mayer and Gladys Keating volunteered to research Virginia legislation relating to suits against volunteer organizations, and Martie Klee will check with EIN for any information they may have. A decision about increasing or changing our current coverage will be made at the September 13 Board meeting.

Membership

Laura Charron reported that our membership currently stands at 315. She indicated that most renewals come due in August and September, and new memberships balance out non-renewals.

Trips and Tours

- Louise Sousk advised that, overall, our trips have made money, The Board unanimously approved two motions for two overnight trips for 2003: to Myrtle Beach, SC, April 28-May 2; to New York City in October.
- The Study/Travel group will hold its first meeting of the Fall session on September 18, 2002 to plan for its next sojourn.

Academic Program

Doris Balinsky briefly reviewed the Fall 2002 program, which has a wide variety of courses that will be easier to read in the catalogue: the course number will be preceded by the last number of the current year and the corresponding session (e.g., F for Fall, etc.) The number will be followed by an "A" or "P" (for a.m. or p.m.), and the description will allow members to

- see date, time, location, and leader at a glance.
- Several courses already have been identified for the Spring session, and Doris indicated there will be an effort to find more instructors for science classes.
- Two volunteers, Norma Hughes and Jack Wyatt, edited the Fall catalogue, and Norma will assume the Program Committee chair responsibilities for the Summer 2003 session.
- It was suggested that the Fall 2003 classes start in mid-September, rather than at the end of the month.
- John Manion and Gordon Hamlet will be responsible for reserving spaces for classes.

Special Events

Virginia Fernbach reported on special events held during the past year. While the May appreciation reception was very successful, a large number of members made reservations but failed to attend, resulting in a waste of money since more food was catered than was needed. It was agreed that a notice would be placed in the newsletter asking members to honor their reservations or call to cancel.

Outreach

- Martie Klee indicated that the Elderhostel Institute Network (EIN) has dropped its dues requirement, thus saving LLI \$600/year.
- LLI will have an information table at the September 17 Health and Wellness event being held at The Virginian.
- Alan Mayer hopes to meet with NVCC's Provost in August to discuss scholarships.
- Don Reynolds and Memphis Norman previewed a slide program on LLI's history that is being developed for our tenth anniversary in 2006.

During the retreat wrap-up it was very gratifying to hear Knox express his amazement at and delight in LLI's progress from its inception to the present.

Advice for Victims of Identity Theft

In the March issue of *eNews*, we told you about identity thieves and how they can use your Social Security number for their personal gain. We suggested ways to protect your personal information, including your Social Security number. But if you do become a victim of identity theft, there are ways to recover your good credit rating. Report it to the Federal Trade Commission's ID Theft Hotline, 1-877-IDTHEFT. You also should contact the three major credit bureaus, tell them you're an identity theft victim, and ask them to place a fraud alert on your record. The credit bureaus are:
