he LLI Trip Committee met on Monday, October 5. At this meeting we discussed the remaining trips for 2009 and tentatively scheduled a number of upcoming trips for the year 2010.

Read **MARGARET REED**'s story below (some of you will have heard her speak at the October Forum):

"In 1981, I made one of the biggest mistakes of my life when I dropped out of high school. In 2000, I took the first step toward reclaiming my education by taking the GED and registering at NVCC. I had not been in a classroom for twenty years and I had my doubts that I belonged in the world of academia. When I was selected by LLI to receive the **STUDENT LEADERSHIP AWARD** in 2003, I was at a critical point when I had to decide whether or not to continue my education beyond NVCC. In addition to being a nontraditional full-time student, I am also a wife, mother, and grandmother, as well as the primary caregiver to my mother who is 84 and has been bedridden since 2002. Your award helped give me the

confidence to reach for the stars. Since then, I graduated Summa Cum Laude from NVCC with two degrees, an A.A. and an A.S. I entered George Washington University, where I graduated Summa Cum Laude in 2008 with a B.A. in History and Women's Studies. I am currently a M.A. candidate in the History department at GWU; my specialty is Early American Women. I am working on my M.A. Thesis about women who became property owners through Revolutionary War land grants. I will graduate in May 2010 and will be submitting applications for doctorate programs. This semester I received a teaching fellowship at NVCC and I have come home to teach History 121. I hope to give my students the same encouragement that was given to me by you and NVCC. Thank you for your dedication to the students at NVCC and your tireless devotion to education."

LISA BORGES, winner of our **2008 LEADERSHIP SCHOLARSHIP** is another outstanding achiever. She writes:

"I graduated Summa Cum Laude from NVCC in May 09 with an Associate of Arts, Liberal Arts, Degree and a Promotions & Public Relations Career Certificate. I am currently employed by Alion Science And Technology, but have taken a Leave of Absence for the semester so that I can finish working on my

Bachelor's Degree. Although I am attending George Mason University, my credits are being transferred to Syracuse University from which I will receive a Bachelor of Arts Degree in 2010 with a major in Television, Radio and Film and a minor in English & Textual Studies. Provided I am able to extend my Leave of Absence, I will go to Egypt for two weeks to take my final English course which involves studying culture and literature from that area of the world. Further accomplishments after receiving your award,

prior to my NVCC graduation, I was nominated to be President of Phi Theta Kappa for 2008–2009 but, as a Navy Reservist I had received orders for Iraq and had to resign the position. Within a few weeks of resignation, my orders were cancelled, so PTK made me Co-Chair of the Relay For Life of NVCC. Despite the nation's economic situation, we, NVCC, were able to raise approximately \$34,000 to support the American Cancer Society. As a Navy Reservist, I was nominated Sailor of the Quarter, first quarter 2009, and am responsible for running the assignments of our Operations Department. I am working toward making Chief Petty Officer, E-7. I am very appreciative to your committee for awarding me the LLI Leadership Scholarship. It served me greatly in completing my education at NVCC."

Important Safety Reminder

o you have a fire extinguisher in your home or kitchen area? A portable fire extinguisher can save lives and property by putting out a small fire or containing it until the fire department arrives. However, because fire grows and spreads so rapidly, the *number one* priority for all residents is to get out safely. Install the extinguisher close to an exit and keep your back to a clear exit when you use the device so you can make an easy escape if the fire cannot be controlled. Fire extinguishers are one element of a fire response plan, but the primary element is safe escape. Every household should have a home fire escape plan and working smoke alarms.
