What You Always Wanted to Know About Medicare, Supplemental Plans, and Related Health Issues

"Mr. Medicare" is the name some people in Fairfax County call our expert speaker, Howard Houghton. Mr. Houghton is the Program Coordinator of the Virginia Insurance Counseling & Assistance Program (VICAP). This is a free counseling program for individuals who need help understanding Medicare, Medicare supplemental health insurance, managed care plans, Medicaid, long-term care insurance, prescription assistance plans and medical billing issues. Mr. Houghton supervises 18 counselors who are trained on most health insurance issues, and have been certified by both the Virginia Department for the Aging and the Virginia Bureau of Insurance to provide counseling on these matters. Mr. Houghton will provide some history about the fight for Medicare and give us a most interesting look at how Medicare is administered and how the program is likely to fare under the proposed health reform plans.

President's Message

emember that we describe our organization as "LLI/NOVA is a non-profit, member-run organization dedicated to providing continuing 'educational opportunities to older adults." This month I want to look at the "non-profit" aspect. It is typical to be concerned about the "bottom line" for a profit-making company and be sure the profit is there. Sometimes when we are associated with a non-profit organization, members tend to forget about the financial part; somehow, the money takes care of itself. Just the opposite is true, and it is important to keep a close watch on financial aspects. For LLI this starts with an accurate record of all expenses and our fastidious watcher is the treasurer, Phil Runge, who makes sure every expense and deposit is appropriate, fully documented, and carefully recorded. Our administrator, Laura Charron, keeps a close watch on the office expenses and the receipt and deposit of membership dues and other checks. We need to be sure all of these follow a plan, which is the budget.

The budget committee under Bob Huley prepares the draft budget which is approved by the board and then the general membership. During the year, the budget is adjusted if required to accommodate unexpected changes. In addition, there are certain items such as trips, special events, scholarships, special class costs, etc., which are self-supporting and outside the budget, but must be watched just as carefully. At each board meeting, all income and expenses are reviewed and each board member is responsible for certain accounts. The board is also developing a series of policies that address critical financial issues. As an overall check, each year we request an external member-run review of the finances. Last year this was compiled by an audit committee headed by Karren Scott; this year the committee was headed by Charles Hulick. These committees provide a close watch on our procedures and yield excellent suggestions on how to improve our approach.

The end results, of course, are to make sure the funds are spent appropriately and we neither over spend nor make a "profit." There are variables that complicate the process. To protect against a shortage, the board has designated \$12,000 (about three months' expenses) as a special reserve that can only be used when the organization is in extreme financial trouble. Over the last few years, due to efficient management, our non-critical reserve has continued to grow. The board is exploring how these funds can be used to efficiently and effectively improve the operation of LLI/NOVA and we welcome your input.

Food donations will not be collected in December. For the January 12, 2010, Forum, Food for Others is once again the designated recipient of the LLI food donations. As a regional food distribution organization, Food for Others distributes

food throughout Northern Virginia in three ways: at their warehouse, emergency food is provided daily to an average of 60 families and individuals referred by social services organizations; every weeknight, food is distributed at 14 sites in high poverty neighborhoods in Arlington, Falls Church and Fairfax; and throughout the year, bulk food distributions are provided to more than 40 community-based organizations, including churches, soup kitchens, homeless shelters and day care and community centers. While all donations are appreciated, current needs include canned fruit, pasta sauce, jellies or preserves, and canned chili. Bev Portman will deliver the January LLI donations.

Last month LLI members donated 105.5 pounds to the Koinonia Foundation.
