FAIRFAX COUNTY URBAN SEARCH AND RESCUE TASK FORCE



The Fairfax County International Urban Search & Rescue (US&R) resource, sponsored by the Fairfax County Fire and Rescue Department, responds to both domestic and international disasters. Since 1986, Task Force members have been at the forefront in assisting in the development of response systems both domestically and internationally. At our Forum they will share their history and many real-life emergencies to which they have responded. They make us proud, so don't miss this chance to show our support and to learn about their work.

There are approximately 200 trained and equipped members on the Task Force, including 70 volunteer and career firefighters and paramedics from the Fairfax County Fire & Rescue Department, as well as many highly trained civilians. The latter includes physicians, canine handlers, structural engineers, communications experts, and heavy rigging specialists. Deployed with little or no advance notice, members and their families must be able to accommodate and adjust to restrictions of a 14-day mission, often without communications home. Non-deployed co-workers often work extra shifts while the Task Force is away.

The Task Force works with USAID, FEMA, and the UN, and is a premier leader in providing training in catastrophic event mitigation, readiness, and response and recovery techniques. By assisting in the development and enhancement of other search and rescue resources, the Task Force lessens the necessity of being deployed. It is proud to be one of only 28 domestic resources qualified by FEMA to assist with Homeland Security, and one of two resources utilized by USAID for international response.



President's Message

I mentioned in last month's newsletter several initiatives that your LLI Board has been taking to grow our membership back to pre-pandemic levels. One of them is the collaboration between LLI and Arlington-based Encore Learning (EL). Both organizations offer continuing education classes, Special Interest Groups, local excursions, and socializing opportunities. Our differences include class duration, scheduling (EL does not have a summer session), LLI's Study/Travel Program, and fee structures. Two of the initial steps in the collaboration include (1) mentioning a few of each other's programs on our respective websites and newsletters and (2) making several classes mutually available to our memberships. Several EL members participated in our City Nature Challenge on May 1 at Mason District Park. We are discussing offering EL members the opportunity to attend "summer camp" memberships that would allow them to participate in LLI's summer programs - and also to join as full LLI members if they choose. Julianne Wojay, a member of both organizations, has been the driving force behind this collaboration.

This month's "shout-out" goes to LLI/NOVA's Curriculum Committee Chair, Dick Robison. Dick has been an LLI member since 2010, has

served as chair of the Curriculum Committee since 2019 and as a Board member since 2020. He and his committee have consistently presented LLI members with interesting and stimulating classes – about 130 in this fiscal year alone. Dick attends almost all of the classes, recruits and assists all of the class coordinators, and has been helpful in providing class and instructor contact information to groups with whom we are collaborating. Dick has hosted every Zoom Forum and Board meeting over the last year. I have come to rely on Dick's wise counsel, thoughtful advice, and timely technical assistance. Thank you, Dick!

Voting for LLI/NOVA 2022/2023 Board Members and Officers



The election for LLI/NOVA's 2022/2023 Board of Directors and Officers will take place on June 1 at 9:30 a.m. at our annual membership meeting. The

election requires a quorum, so if you know in advance that you won't be able to vote on June 1, please send an email to Pat Neri to vote for our slate of candidates. You may vote on the entire slate at once (i.e., "I approve the slate of board members and officers proposed by the nominating committee, as listed in the May newsletter.") Our Board of Directors is made up of 15 members elected by the membership. Board members serve a three-year term with five Board member terms expiring annually. If a position becomes vacant, a new member is elected to complete the unexpired term.



FY2023 Budget

LLI's bylaws require that the Budget & Finance Committee present our annual budget to our membership at the annual membership meeting. The LLI Board of Directors approved our fiscal year 2023 (July1, 2022 to June 30, 2023) at its May 13 meeting. The budget is included in this newsletter (see page 8) and will

be reviewed at the annual meeting on June 1.

Membership dues are our primary source of



Our expenses are largely fixed – our largest expense is our part-time administrator, followed by rent for the Ernst Center, and classroom rental. Our FY2023 budget includes six in-person Forums and three Zoom Forums.

Holding three Forums via Zoom reduces our costs, eliminates the possibility of having to cancel Forums due to inclement weather in the winter, and provides the opportunity for interesting speakers from outside Northern Virginia. To reduce costs, we will provide coffee only at our first in-person Forum. Restassured that goodies will still be available!

Due to our reduced membership levels, holding dues to \$110 per year, and our largely fixed expenses, our approved budget projects a significant deficit for FY2023. Because of very conservative financial management of LLI/NOVA funds during the past 25 years, we currently have sufficient net assets (i.e., savings, both in operations funds and an emergency fund) to offset this year's expected budget deficit. LLI/NOVA remains very healthy financially, but the real key to our continued organizational health is recruiting and retaining members.

SCOTUS: Where Will the Wall of Separation of Church and State Be?

Speaker: Rob Boston, Americans United for Separation of Church and State, author

According to <u>Thomas Jefferson</u>, the First Amendment to the Constitution erects a "wall of separation between church and state" making the U.S. the first country to do so. Should nationalism movements change that?

The strength of that wall has varied over the years, and some scholars contend that recent U.S. Supreme Court (SCOTUS) decisions are

undermining it. Our speaker will address the ramifications of this and related topics:

- Role of religion in public education
- Tax funding of religious entities
- Intersection between religion and politics
- LGBTQ bullying, equality, and suicide
- Government's use of religion in a symbolic manner
- Resurgence of Christian nationalism as a political force

Rob Boston has worked at Americans United for Separation of Church and State for nearly 35 years and has authored four books on church-state relations. Prominent media appearances include CNN, <u>NBC Nightly News</u>, Fox News Channel's <u>The O'Reilly Factor</u> and MSNBC's <u>Countdown with Keith Olbermann</u>.



In Memoriam for Marion (Moe) Moser



Longtime LLI/NOVA member Moe Moser passed away April 15, 2022. Moe joined LLI/NOVA in August 2004 along with his late wife, Ginny, and soon became an active participant. He served on the Curriculum Committee for several years, acquiring classroom space for our courses. Moe was described as unflappable because this task required him to deal with many venues, including various churches, retirement communities, and NOVA Annandale, along with a variety of contact persons, while always striving to keep our costs to a minimum. He accomplished all this in a quiet, seemingly effortless manner, and always with a smile. Moe served two terms on the Board of Directors (July

2008-June 2011 and July 2011-June 2014), and was an integral part of the Forum Committee, researching and arranging for the many quality speakers we have enjoyed for years at the LLI/NOVA Forums. He served on the Nominating Committee for two years and was the official LLI/NOVA photographer for many years, taking photos at the Forums, social gatherings, and other events. Moe also provided assistance to the Trips Committee, arranging for day and overnight excursions.

In March 2016, Moe was featured in the LLI/NOVA newsletter "Honor Circle" where he was recognized for his many contributions to LLI/NOVA. In particular, he was commended for his good humor, friendliness, and the good will he made for LLI/NOVA through his contacts, along with his willingness to generously volunteer his time on our behalf.

Moe and Ginny became involved in the Unitarian Universalist Church while living in Chicago, and they were instrumental in the establishment of the Accotink Unitarian Universalist Church in Burke, Virginia, where they both sang in the choir. Moe also enjoyed playing bridge and attending his grandchildren's sporting events, plays, and musical performances, and was a dedicated fan of the Washington Nationals.

Moe was born in Dalton, Ohio, and was the grandson of a Mennonite minister who conducted services in German. He graduated from Kent State University, where he received both his B.A. and M.A., and was president of the Sigma Phi Epsilon fraternity. After college, Moe met Ginny on a blind date while he was waiting to enter the U.S. Navy. He always said, "She was the best thing that ever happened in my life." Moe served in the Navy for two years before settling in Virginia. He worked at the Office of Personnel Management and retired after 25 years of service after which he worked as a consultant.

In learning of Moe's passing, several LLI/NOVA members described him as "a true gentleman who treated everyone with kindness and a smile." His contributions to LLI/NOVA will long be remembered and appreciated.
